Children, setting staff.</p>	<p>Spread of Covid-19 within 'bubbles'.</p>	<p>Guidance regarding shared classroom based resources has been issued by the government to all relevant settings.</p>	<p>Kit box to be situated away from the bubble and accessed only by a bubbles staff member or those wearing a face mask and disposable gloves.</p> <p>Frequently touched surfaces to be regularly cleaned with a sanitising agent. These include the outside of the incubator and the outside of the brooding cage. Surfaces should be wiped and not sprayed to avoid inhalation by the hatchlings or contamination of toxic substances to their living environment. Touching of these surfaces by anyone other than the supervising adult to be discouraged.</p> <p>The hatchlings can be handled as usual but those handling the hatchlings must thoroughly wash their hands with soap and water/use a high alcohol hand sanitiser before and after touching the birds.</p>	<p>Supervising classroom teacher/ manager/ responsible adult.</p> <p>Supervising classroom teacher/ manager/ responsible adult.</p>

Care of the hatchlings may be handed over to another member of staff from a different bubble. Upon handover a face mask and disposable gloves should be worn and all elements of the equipment cleaned. Your Incredible Eggs branch must be informed of the situation prior to collection.</p> <p>or</p> <p>2) Where the above is not possible, the complete kit and hatchlings may be taken home with a member of staff from within the affected bubble and cared</p>	<p>Supervising classroom teacher / manager / responsible adult.</p>
